

Student Group and Organizations with Conduct Violations

A summary of each incident resulting in a finding that a student organization has violated the Code of Student Conduct, the charges the organization was found to have violated, and sanctions that alter an organization's status on campus are listed on this page. As many details as are relevant about the incident and the organization rather than individual students are provided in the summary. Other sanctions that are educational in nature may also have been assigned to organizations but are not included on this page. Beginning in Spring 2024, educational sanctions have been added to new outcomes. **Information on this page is posted for four semesters following the date of the finding or completion of sanctions (whichever is longer)** to show an organization's history and identify an organization's work towards changing the culture of the group.

Status Sanction Definitions

- **Warning:** An initial directive against similar behavior in the future. For purposes of external reporting, cases resulting in a warning do not create a student conduct record that is subject to release unless a subsequent violation occurs.
- **Censure:** An official written reprimand for violation of specified regulations including a warning that continuation or repetition of prohibited conduct will be cause for additional disciplinary action.
- **Disciplinary Probation:** Period of probation where additional restrictions or conditions may be assigned. Violations of the student's probation or additional violations of this Code or other university policy during the period of probation may result in removal from housing, suspension, or expulsion from the university if the student is found in violation of new charges.
- **Limitation of Privileges:** The organization is limited to a specific number of social events/activities with alcohol present.
- **Social Probation:** The organization is unable to host social events/activities with alcohol present.
- **Removal of Housing Lease Agreement:** The organization's lease for University-owned housing is terminated.
- **Suspension:** The organization's recognition is suspended by the University for a period of time. The suspension may see extension of disciplinary probation provided that the organization complete the requirements outlined from a disciplinary hearing. Further violations could result in the revocation of the organization's University recognition. The organization loses all access to university privileges and may not function or operate in affiliation with the university. Organizations with national affiliations may lose privileges associated with the status.
- **Revocation of Recognition:** The organization's recognition is revoked by the University. The organization loses all access to university privileges and may not function or operate in affiliation with the university. Organizations with national affiliations may lose privileges associated with the status.

Educational or Active Sanction Definitions

Most organizations receiving a disciplinary status sanction assignment will also be assigned educational or active sanctions.
